## MINUTES OF VMC MEETING DATED 09/12/2010

The members of VMC, KV Barkuhi convened a meeting on 09<sup>th</sup> Dec. 2010 at 4.00 pm. The meeting was headed over by Mr J Dasgupta, SO(C), WCL and Nominee Chairman. The Co- opted Member Mr Gulam Hussain, PM (Welfare), WCL and other members recorded their active participation. The minutes of the meeting are as follows:

- 1. Procurement of potable water: The Principal brought it to the notice of all members that the drinking water in the Vidyalaya is provided by the WCL by means of Water Tanker. But, the tanker often fails to reach Vidyalaya which consequently arise lot of problem for the students. Mr Ghulam Hussain and Mr J Dasgupta assured that the matter will be dealt seriously and the employee in charge for this supply of water shall be instructed accordingly.
- 2. Additional Toilets for visitors, staff and the physically challenged ones: The matter was raised before the committee that every year there is an increase of one new section. So far six new sections have been increased in the Vidyalaya but no more construction of toilets was done which is creating problem to everyone. It was assured by the WCL authorities that the estimate for the construction of additional toilets shall be given in the budget of next financial year.
- 3. Construction of 05 new classrooms, sanction for opening of a new section in class 6<sup>th</sup> during 2011-12 and furniture: The members unanimously agreed for opening of a new section in class 6<sup>th</sup> during 2011-12. And, Mr. Ghulam Hussain said that the amount required for construction of 5 new classrooms and furniture shall be mentioned in the budget (Capital Fund) for the financial year 2011-12.
- 4. Canteen facility in the Vidyalaya: As the students in the Vidyalaya are coming from far and flung area, the necessity of canteen was realized by one and all. The WCL authorities suggested that they may send a reliable vendor during school hour. They also asked the Principal to provide a tin shed for selling of items in a corner of Vidyalaya on which, the Principal agreed.
- 5. Regular Power Supply in Vidyalaya: Due to frequent power cut, it has become impossible for the teachers to deliver their lessons through LCD Projector. The computer classes of the

students and the official works are also being suffered. Mr Hussain ascertained that he will instruct the employee in charge of electric supply to provide full time electricity in the Vidyalaya.

- Repairing of Electric Wiring: Mr J Dasgupta agreed for the immediate repairing of electrical wiring by WCL.
- Installation of Sodium Vapour Lamps: Mr Gulam Hussain agreed presently to provide 02 halogen lamps.
- 8. Repairing of Window Pans: Mr Dasgupta informed that the repairing of broken window pans shall be done during this financial year.
- Cementing of Morning Assembly Ground: As the provision for this was not incorporated in the budget of 2010-11, the same work could be done during the next financial year.
- 10. Installation of six exhaust fan: Mr G Hussain agreed for installation of six exhaust fan in computer laboratory during current financial year.
- 11. Payment of Employees due 60% Arrear as per 6 CPC and Administrative Overhead Charges: The Principal and the Teacher Member brought this fact before the committee that for about one and half years they are only getting the assurances from the Project authorities regarding payment of employee's 60% due arrear. However, inspite of the KVS HQ letter that the said amount must be paid before 31st Mar 2010 and the fact that KV employees of almost all other KVs( except the 3 KVs under WCL) have got their due arrear during last session, here, the employees have still been kept deprived of arrear payment. Mr Hussain informed that the amount will be paid in Jan 2011. Regarding Administrative Overhead Charges, PM (Welfare) asked Principal to bring the letters in this regard.

The meeting continued up to 2hrs. and came to an end at 6.00 pm.
