

Minutes of VMC held on 16-03-11 at KV Barkuhi

The concluding VMC Meeting for the session 2010-11 was held on 16-03-11 at 4.00 pm in the premises of KV Barkuhi. The Meeting started with the formal Invocation and welcome of revered Committee members by The Principal / Member secretary, VMC Sh. H S Pandey.

Agenda put out for discussion are as follows :

- * Payment of 60% Arrears as per 6 CPC
- * Payment of Overhead Charges
- * Discussion on academic standard and other activities and their improvement and other infrastructure of vidyalaya
- * Procurement of Furniture for the newly opened section in class VI.
- * Change of school timing for the vidyalaya
- * Repairing of culvert on the road adjoining Vidyalaya
- * Canteen Facility in Vidyalaya
- * Interview for Part time Contractual Teachers
- * Any other relevant points

The committee discussed the above mentioned agenda at length and the following resolutions were passed for the smooth and effective functioning of vidyalaya

*** Payment of 60% Arrears as per 6 CPC:**

Mr Gulam Hussain, PM (Welfare), WCL, Pench Area informed committee members that the provisions for payment of 60% dues as per 6 CPC has been made in the Budget. After the Principal insisted that the employees of this Vidyalaya have already waited for a long period contrary to other employees of KVS who have got their arrear during the last financial year 2009-10, Mr G Hussain assured that the amount for the same shall be released before 25th March 2011.

*** Payment of Overhead Charges:**

The Principal pointed out the fact that inspite of many reminders by KVS and discussions in previous VMC meetings, WCL has not cleared up the dues standing against the Overhead Charges. Mr Gulam Hussain assured that an early action in this regard shall be taken and a letter in this regard shall immediately be sent to Head Quarter, Nagpur for necessary action.

*** Discussion on academic standard and other activities:**

The committee discussed the academic standard of the vidyalaya at length and suggested to achieve academic excellence by all means. The Principal briefly introduced committee members about the co-education introduced by CBSE and also made them aware of its implementation in the Vidyalaya. Besides, a brief account of efforts made for the students appearing Board Examination (extra remedial classes) was given by the Principal. The committee appreciated the works/ activities carried out by the school administration during the session 2010-11.

• **Improvement of other infrastructure of Vidyalaya:**

The Principal expressed his thankfulness to WCL authorities for initiating the repairing work in the Vidyalaya. The committee members were informed that the mending work of roof for preventing seepage of water is going on. The parapets have been broken and their repair is also being done.

• **Procurement of Furniture for the newly opened section in class VI:**

It was informed to the committee members that there will be an increase of a new section in class VI in session 2011-12. And, furniture for the same is required. Mr Hussain agreed to make provisions for procurement of furniture in the Budget.

• **Change of school timing for the vidyalaya:**

The Principal submitted a proposal for change of Vidyalaya time. The normal timing of Vidyalaya was shifted on account of extreme cold but as the days have become hotter, the normal timing of Vidyalaya may be retained. The proposal was accepted and it was decided to follow the normal timing of Vidyalaya from 1st April 2011.

• **Repairing of culvert on the road adjoining Vidyalaya:**

The culvert on the road adjoining Vidyalaya is damaged and so it has become very difficult for the school buses to cross that. Also, to avoid any mishap, it is essential to repair that culvert. The problem was realized by all members and the WCL authorities agreed to take necessary action.

• **Canteen Facility in Vidyalaya:**

The Principal informed the committee that the students are coming here from far areas and they have to stay here for a long time so there is necessity of a canteen in the Vidyalaya. It was reminded that the matter was also discussed in the previous meeting. It was decided that a reliable vendor from outside may be invited and be allowed to sell his materials during recess.

• **Interview for Part- Time Contractual Teachers:**

It was decided to conduct interview on 25th March 2011 for the preparation of panel against all posts. Stress was given on selection of well qualified and competent candidates.

At the end, Principal in his concluding address stressed the need to have a long term plan with broad vision for the future and development of the vidyalaya in all fronts.

The Meeting ended with the vote of thanks by The Principal to all the members for their active participation and fruitful suggestion.
