

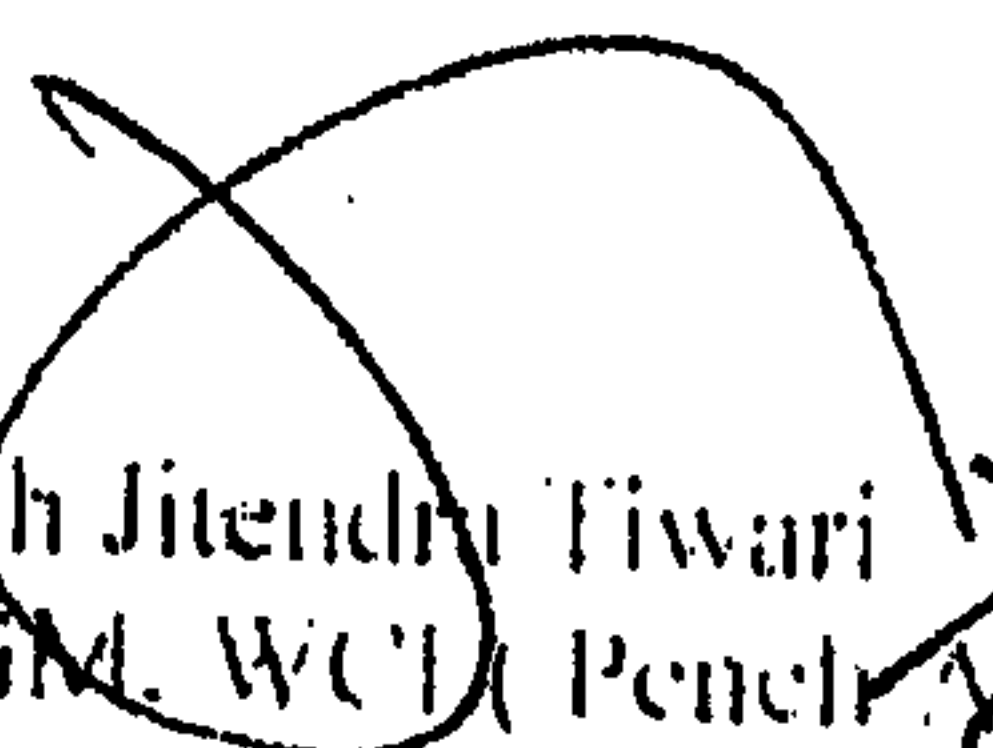
Minutes of 1st VMC dated: 05/08/2010

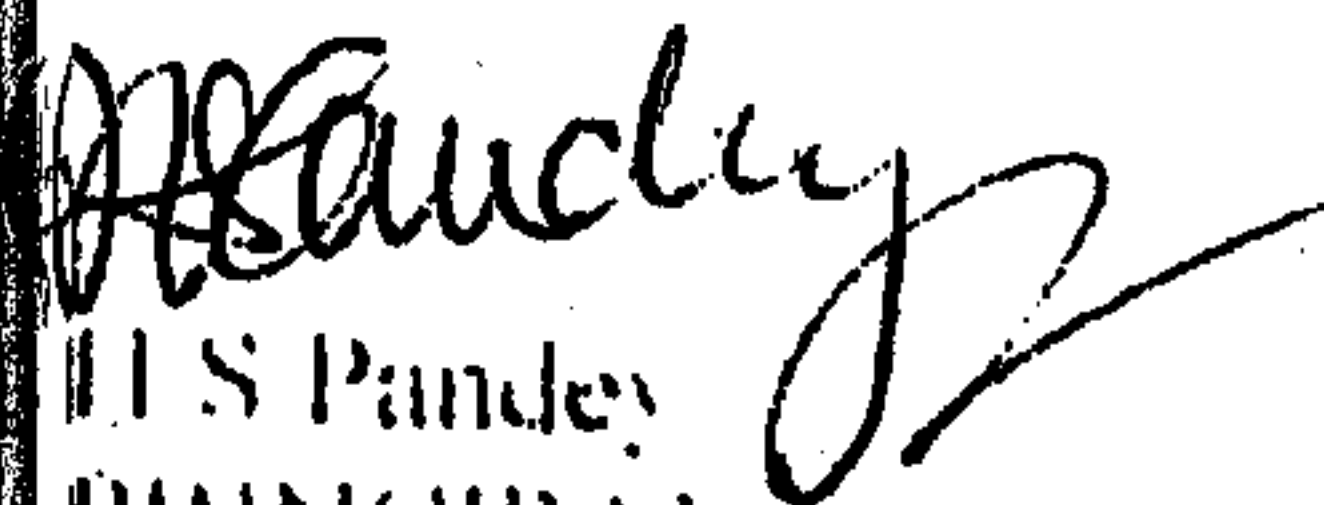
The first VMC meeting for the session 2010-2011 was convened on 05 Aug 2010 at 3.00 pm. The meeting was headed by the Chairman's representative and co-opted member of VMC, Mr Gulam Hussain, PM (Welfare), WCL (Pench Area). Different issues related to the students, school infrastructure, financial exigencies and employees' welfare were presented before the committee and the under mentioned decisions were taken by the committee.

- 1. Potable water and water cooler:** Due to insufficient supply of water from Pench water pump, it was decided to continue with the supply of water from tankers. The members decided for installation of two R/O systems to provide potable water to the students and assurance for the same was given by the project authority. Regarding water cooler, Mr Gulam Hussain said that the Project shall provide the same during the next session. And, by that time, Vidyalaya can purchase one water cooler from VVN fund after getting approval of the Chairman.
- 2. Furniture:** Principal extended his gratitude to the Project authorities for taking efforts to repair the old furniture. Mr Hussain assured that the old desks and benches which have not been repaired shall also be repaired soon. He also added to provide him the requisition of furniture required for the next session within a week.
- 3. Construction of Additional Toilets for Physically challenged, visitors and staff:** All members of VMC agreed on the point to construct additional toilets in the empty space near the septic tank. Also, assurance was given for the provision of running water facility in all the toilets.
- 4. Provision for Ramp:** The members during meeting realised the necessity of ramp in Vidyalaya for physically challenged students and even the students who get severe injury in their leg. Mr Hussain and Mr Dasgupta agreed for construction of ramp in the Vidyalaya.
- 5. Repairing of the damaged school road, road near entrance and building of an arch at entrance marked name of the Vidyalaya:** The Principal brought in the notice, of the pit that has occurred on the way leading to the school and may cause any mishap at any time. The Project authority agreed for its immediate repair and at the same time the request for repairing of road near the entrance and building of an arch at the entrance was also considered.
- 6. Sodium Vapour / High Power Light:** Mr Gulam Hussain on the request of committee members agreed to install two sodium vapour/ high power lights at the front portion of the Vidyalaya.
- 7. Fitting of Glass Panes in the windows:** Mr Dasgupta assured that the work shall be done within a month. The members requested to use unbreakable sheet for the purpose on which he agreed.
- 8. Covering of Drainage:** Feeling the necessity of the work, decision was taken to cover up the drainage systems which are open.
- 9. Seepage and leakage in the roof:** Project authorities agreed to arrange the required repairing to prevent seepage on priority basis.
- 10. Staff Quarter:** It was pointed out that the quarters which are allotted to the staff are in a worst condition. Project authorities agreed to repair these quarters when the repairing of other quarters of Doctor's Colony shall be done.

11. **Timely Payment of Salary:** It was decided that all efforts shall be made for timely payment of salary.
12. **Increase the amount released by the Project for Salary and other reimbursements:** The matter was presented by the Principal stating that the amount of about 1450000/- which was released for these purposes was not sufficient. At least, an amount of Rs 1600000/- should be released as an increment of 3% is granted to all the staff in the month of July. Besides, DA from July has also increased and many activities related with sports are to be conducted at cluster, regional and national level. Mr Gulam Hussain realising the necessity of enhancing the amount asked to send project office a copy of government's order for increase of DA.
13. **Payment of due 60% arrear as per 6th Pay Revision:** Mr Ghulam Hussain stated that the work is under process and the efforts are being made. The fund for the same may be made available by the end of Aug 2010.
14. **Proposal for Budget Estimate:** The same was produced before the committee and it was advised to send its copy to WCL office for necessary approval.
15. **Medical facility to the KV employees:** Mr Ghulam Hussain asked to provide him an agreement copy, after having perusal on it any decision shall be taken.

The meeting continued for 2 hours and came to an end at 5.00 pm.
